




Sector allocation

Commentary

The Diversified Share Fund returned +7.0% (Wholesale) over the quarter (Retail fund returned 6.9%), outperforming the benchmark (75% S&P/ASX 200 Accum Index / 25% MSCI World ex Aus Index) which returned +6.4%.

The domestic portfolio (75% of the total fund) increased by 8.5% versus its benchmark ASX200 which increased by 7.8%, resulting in outperformance of +0.5% (before fees). The international portfolio increased by 3.6%, outperforming its benchmark (the MSCI World ex-Australia) by +1.3%.

In the domestic portfolio, the zero exposure to the Energy sector positively contributed to outperformance. The overweight exposure to the Real Estate sector was also a positive contributor as stocks benefited from attempts to position ahead of the rate cutting cycle. The underweight exposure to Materials negatively contributed to performance, as the sector rallied following PBOC announcing a raft of measures to stimulate the flagging Chinese economy and revive the housing sector.
